Section 8: Cast Member Requirements:

1. Cast members must attend all scheduled rehearsals. Any conflicts not listed on the front of the audition form must be approved by the director. Unexcused absences may result in the cast member being replaced in the production.
2. A child must be at least six (6) years of age by the date of the first performance to audition for any KVTA production. No individual older than 16 years of age by the date of the first performance is eligible to audition for a YPT production. Proof of age may be requested.
3. If this is a Young Peoples Theatre production, all actors will miss two (2) days of school to appear in the scheduled school performances.
4. All cast members must complete a minimum of 10 hours of volunteer technical work when cast in a KVTA production. Cast members 17 years of age and older, when necessary, may designate another adult to fulfill the requirement. Parents of children ages 16 and under must fulfill this requirement for each child cast in the production.
5. If cast, actors must furnish shoes, including both dance and/or street shoes, and any items of a personal nature. KVTA will furnish period costumes, however, assistance in obtaining accessories or special costume pieces may be requested.
6. KVTA is a family-oriented organization. Please remember that while participating in a KVTA sponsored function, what you say and do is not only a reflection of your values, but of KVTA's as well. Appropriate language and dress is expected.
