- 2. Cast members must attend all scheduled rehearsals. Any conflicts not listed on the front of the audition form must be approved by the Director. Unexcused absences may result in the cast member being replaced in the production.
- 3. A child must be at least 16 years of age by the date of the first performance to audition for this production. Proof of age may be requested.
- 4. All adult cast members are asked to complete a minimum of 10 hours of volunteer technical work when cast in a KVTA production. Parents of actors ages 17 and under may fulfill this request for each child cast in a KVTA production. Cast members age 18 and older, when necessary, may designate another adult to fulfill this request for them (example: someone age 18 in a show can't fulfill his/her 10 hours so their adult sister volunteers and completes them for the cast member).
- 5. If cast, actors must furnish shoes, including dance and/or street shoes, and any items of a personal nature. KVTA will furnish period costumes; however, assistance in obtaining accessories or special costume pieces may be requested.
- 6. KVTA is a family-oriented organization. Please remember that while participating in a KVTA sponsored function, what you say and do is not only a reflection of your values, but of KVTA's as well. Appropriate language and dress are expected. A signed KVTA policies acknowledgement form will be required.
